BEST OF BREED: At the discretion of the Judge, up to three (3) Awards of Merit to be awarded to dogs or bitches entered in this class, except those winning BOB, BOS, BOW, WD or WB.

Bred by Exhibitor (BBE) Class Eligibility (revised 09/02)

- All dogs entered in the Bred by Exhibitor Class must be **individually registered** with the AKC.
- The person handling the dog must be a breeder of record of the dog and an owner of record of the dog.
- To exhibit in this class, family members must be a breeder and owner of record.

NON-REGULAR (ADDITIONAL) CLASSES INVOLVING SINGLE DOG ENTRIES

Veterans Class – Class for dogs and class for bitches 6 years of age or older. **Veterans Note:** 1st place winners of Veteran Dog & Veteran Bitch classes are eligible to compete for Best of Breed if undefeated in any other classes at this show. Neutered Dogs and Spayed Bitches may be entered.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS – For Stud Dog and two or more of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but **MUST** be entered in the Stud Dog Class, the Get **MUST** be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

BROOD BITCH CLASS – Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS – Two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner.

TEAM CLASS – Four dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in team competition must have at least one common owner.

No Junior Showmanship Classes.

MOVE-UP POLICY FOR THE SPECIALTY AND TRIALS: The Club will permit a move-up to the next level class in accordance with AKC regulations. The request for a Move-Up must be made in writing and presented to the Show Secretary or Trial Secretary at least 30 minutes prior to the start of the specified event, show or trial. Move-Up forms will be available at the Secretary's Table.

NON-REGULAR CLASSES

Pre-Novice Class. The Pre-Novice Class shall be for dogs that have not received a third qualifying score in a Novice Class prior to the closing of the trial. The owner or any other person may handle dogs in this class. Owners may enter more than one dog in this class. However, if a person has handled more than one dog in the first four exercises, that person must provide a handler for the additional dog in the same Group Exercise.

Graduate Novice Class. The Graduate Novice Class is for dogs that have not been certified by a judge to have received a third qualifying score toward a CDX title prior to the closing of entries. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. **However, if a person has handled more than one dog in the first five exercises,**

that person must provide a handler for the additional dog in the same Long Down Group Exercise. If eligible as defined in these *Regulations*, dogs entered in Graduate Novice may also be entered in any other obedience classes.

Veterans Class. The Veterans Class will be for dogs that have an obedience title and are at least 6 years old on the date of the trial. The exercises will be performed and judged as in the Novice Class. Dogs may be entered in another class or classes.

Brace Class. The Brace Class will be for two dogs of the same breed that are eligible under these *Regulations* and capable of performing the Novice exercises. The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled (**the coupling device will not be less than 6 inches in overall length**). **Whichever method is used will be continued throughout all exercises.** A separate official entry form will be completed in full for each dog entered.

CGC Testing

AKC Approved Evaluators: Ms Pamela Murphy and Cotton Silverman

The CGC Test is a certification program that tests dogs in simulated everyday situations in a relaxed non-competitive atmosphere. The CGC Program rewards dogs that have the training and demeanor to be reliable family members as well as community members in good standing.

Some of the Do's and Don'ts for taking this test

- Do** bring proof of rabies vaccination, town licensing, and your own brush.
- Do** make sure your dog is freshly groomed, nails short, ears and teeth clean.
- Do** talk to your dog during all exercises.
- Do** keep your leash loose on all walking exercises.
- Do** take your time.
- Do** bring a buckle or regular slip collar.
- Don't** have treats in your pocket during your testing period.
- Don't** do anything until the examiner tells you to do it. Ask if uncertain.
- Don't** tell your dog to sit if you don't think it will respond.

Irish Wolfhound Foundation Health Testing

Heart Testing

The IWF is sponsoring heart testing on Thursday and Friday, May 20 and 21, from 9:00 am to 5:00 pm. Tests offered include EKGs (electrocardiograms), echocardiograms, (cardiac ultrasounds) and blood pressure screening. Dr. William D. Tyrrell, Jr. veterinary cardiologist, will perform the echocardiograms. Reservations are necessary; sign-up sheets will be available during show hours. Owners pay only \$75 per dog, with the rest of the cost being paid by the IWF. Dogs two years of age and older are eligible. EKGs and BPs are free for those dogs getting echoes. There is a nominal fee for EKG/BP other dogs.

The IWF began offering echocardiographic screening clinics in St. Louis 4 years ago. Veterinary cardiologists Dr. Henry Green and Dr. William D. Tyrrell, Jr., are compiling results comparing data from each dog's EKG to its echocardiogram, and evaluating the accuracy of using EKGs as a screening tool for heart disease in the Irish Wolfhound. The data from this study will also be used to compare health data for wolfhounds in the USA to previously published studies of wolfhounds in Europe.

DNA for Genetic Research/ IW Measurements

The IWF will also be drawing blood for IW genetic health research. This blood is being used for research into bone cancer, lymphoma, heart disease, and other problems which affect our breed.

One of the geneticists whose research may be pivotal to finding the gene(s) for bone cancer is Dr. Nate Sutter of the Sutter Dog Genetics Lab at Cornell Veterinary School. His discovery of an IGF1-like growth factor in dogs was so important that it made the cover of SCIENCE, and interviews with Dr. Sutter were heard on NPR and seen on National Geographic television. The IGF1 gene is of particular interest to us as wolfhound owners, because it has been linked to bone cancer in humans.

Because dogs have been bred selectively over many generations, man has created an enormous size variation. No other mammal species exhibits such size diversity. Dr. Sutter's research may lead to answers to some important questions, such as whether or not extreme variation in size determines which diseases a dog is susceptible to; how important the role of size is in determining the vulnerability of the Irish Wolfhound to bone cancer; and whether or not smaller wolfhounds live longer.

We will be doing six simple measurements, using a cattle wicket for accuracy, and drawing blood from these dogs to use for this research. Each blood sample can also be used for many other future studies of wolfhounds. Extremely large and extremely small wolfhounds are particularly useful. If you are willing to have your IW give blood for research, please stop by the health testing area during show hours.

ATTENTION EXHIBITORS!!

Shade and Water: Shade tents/ex-pens must be at least 20 feet back from the ring. Chairs will be allowed at ringside but no ex-pens or tents (exception will be the tent for judges ringside mentoring and show videographer with narrator).

If a dog is entered in more than one class in the show, the event service fee will be collected on additional entries as well. (American Kennel Club Rule, Chapter 11, Section 2). For All Rally entries, an AKC Recording fee of \$3.00 will be required (Rally Regulations, Chapter 1, Section 3).

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Show Secretary will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis. Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.
