**Eligibility & Pertinent Information:**

Open to all purebred Irish Wolfhounds only. Hounds must be one year or older on the day of the meet. Spayed and neutered hounds may enter LGRA events; bitches in season and lame hounds will be excused.

Race meets will be 3 programs, 4 dog races, 200 yard straight sprints.

**All Hounds will be hand slipped and all hounds will run muzzled. NO EXCEPTIONS. Blankets and muzzles will be available.**

First Time Entered (FTE) hounds will be allowed to compete. ***Owners of FTE hounds must submit a photocopy of your hound's AKC registration with your entry, along with a one-time \$2.00 registration fee.*** All entries must be received 30 minutes prior to roll call. No exceptions made.
