ATTENTION EXHIBITORS

- The State of New Mexico requires a Health certificate showing rabies vaccination within 12 months of entry for dogs 3 months of age or older.
- Tenting and ex-pen set up in designated areas only. There is no tent/ex-pen set up within 10 feet of the ring. NO STAKES will be allowed in the lawn due to underground irrigation.
- Please turn off cell phones and/or pagers before entering rings. Show Chairperson, Obedience & Rally Chairperson and Assistant Show Chairperson have the right to limit cell phone usage within 20 feet of the ring.
- CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.
- DOGS MAY ARRIVE any time prior to their scheduled time of judging. DOGS NOT REQUIRED for further judging will be excused.
- JUDGES DO NOT HAVE TO WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called.
- THE SHOW-GIVING CLUB and the Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
- THE SHOW COMMITTEE/SUPERINTENDENT will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show as well as family, guests, and visitors in attendance.
- CANINE COURTESY. All dogs shall be kept under control at all times. You are responsible for picking up after the animals in your care. You may want to consider crate or X-Pen covers for the comfort of your dog.

Note: Castrated Dogs and Spayed Bitches are eligible for Veteran Classes at independent specialties and by virtue of winning the class, may compete for Best of Breed.

BEST OF BREED COMPETITION

Awards of Merit. At the judge's discretion, he may award up to 3 Awards of Merit to dogs competing in the Best of Breed competition. Not eligible for Award of Merit are Best of Breed, Best Opposite Sex, Select Dog, Select Bitch, Best of Winners.

There will be competition for Best Puppy from the Regular Puppy Classes, Best 6-9 mo. Puppy from the Puppy Classes, Best 9-12 mo. Puppy from the Puppy Classes, Best Bred by Exhibitor.

Gait Class - Following Best of Breed Competition, up to 15 dogs entered in one of the Conformation Classes may compete for Best Gait, judged by Mr. Amoo. The winner of this competition will exemplify the best Irish Wolfhound gait as described in the Irish Wolfhound standard of excellence.

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

Stud Dog Class and Brood Bitch Class: Each entry is allowed two to four get. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Brace Class: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

Team Class: Same rules as Brace Class. Substitute "Four" for "Two" and "Team" for "Brace."

PARADE OF VETERANS - dogs in this class may or may not be entered in a regular class of this show, however, all dogs must be 6 years or older on the day of the show. The Class will not be judged and each entry will receive the special prize of a Dark Green Rosette.

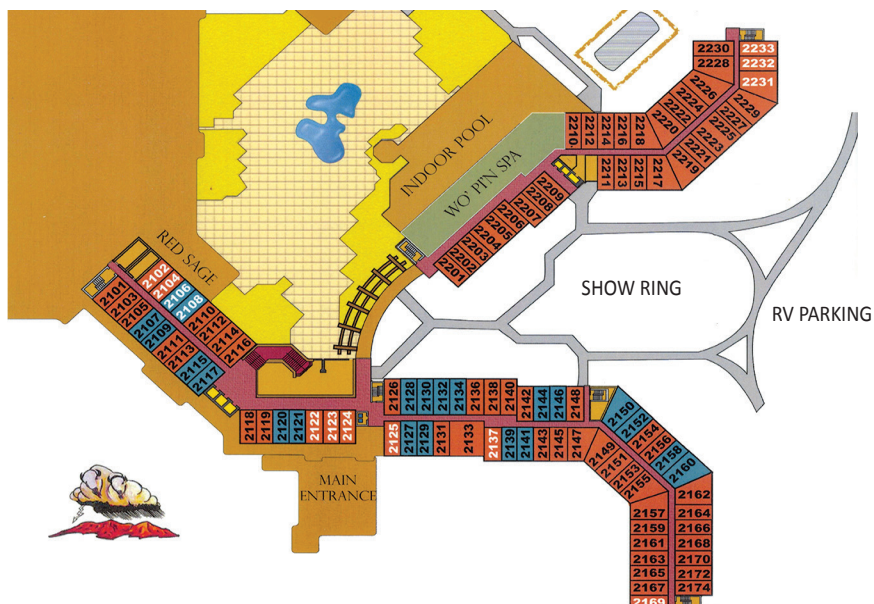

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companionship. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.

Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS' RECOMMENDATION TO ASSURE THEIR DOGS ARE FREE OF INTERNAL AND EXTERNAL PARASITES, ANY COMMUNICABLE DISEASES, AND HAVE APPROPRIATE VACCINATIONS.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.
