<u>Junior Courser (Test A and B)</u>: Open to all all hounds 12 months of age or older. Hounds will be expected to complete a (minimum) 600-yard course with a minimum of 4 turns. The hound must complete the entire course with enthusiasm and without interruption. A Junior Courser Title is awarded to hounds completing two legs of a JC test under two separate judges. Requirements for the JC title will be met at this event.


Qualified Courser (Test):A hound at least 12 months of age (Qualifying Hound) running with another hound of the same breed - or another breed with a similar running style - (Testing Hound) shall receive certification from a licensed judge. The hound must complete the course with enthusiasm and without interruption, sufficiently course the lure and not course the Testing Hound.
