### **Eligibility & Pertinent Information**

Open to all purebred Irish Wolfhounds only. Hounds must be one year or older on the day of the meet. Spayed and neutered hounds may enter LGRA events; bitches in season and lame hounds will be excused.

Race meets will be 3 programs, 4 dog races, and 200-yard straight sprints.

All Hounds will be hand slipped and all hounds will run muzzled. NO EXCEPTIONS. **Bring your own muzzles.** Blankets will be available.

First Time Entered (FTE) hounds will be allowed to compete. Race committee reserves the right to request certification run for FTE hounds. **Owners of FTE hounds must submit a photocopy of your hound's AKC registration with your entry, along with a one-time \$2.00 registration fee.**
