



#### RV PARKING

#### OVERNIGHT PARKING RESREVATIONS ARE CLOSED

Overnight parking will be available beginning at 5:00 pm on Monday, May 13, 2019.

There are no hookups in this lot. There is a nearby full service RV park for sanitary dumping and flushing. If you need electrical power you can use your own generator or rent one at cost from United Rentals at \$65/day for a 30 amp or \$80/day for a 50 amp. (United Rentals, 2707 Cerrillos, Sants Fe, NM 87507. 505-473-2244) You must pick up and return the generator to their location.

- All units must be self-contained. Exhibitors will be responsible for clean-up of their areas.
- No discharge of gray water or sanitary tanks is permitted. You may go to the Road Runner RV park to fill and flush tanks, \$10/visit.
- All set-ups must be made within your assigned space.
- Please, no in & out with RVs during show hours.
- Vehicles in the Park before Monday, if not in their assigned parking spot, will be moved on Monday, May 13, 2019.
- You will be parked at the direction of the IWCA Parking Staff & Show Committee.
- If you go in & out, you must reserve your own site with identification of some type.
- All slide outs must be flagged or coned for safety.
- RV parking is a privilege extended by the IWCA. This privilege can and will be withdrawn from those who do not follow these rules, regulations and instructions of the show committee.

#### TRANSFER OF ENTRIES

NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON FRIDAY, MAY 10. AFTER THIS TIME, YOU MUST CONTACT THE SUPERINTENDENT ON SITE.

**CONFORMATION:** Dogs may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is presented to the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging at the show.

**OBEDIENCE OR RALLY:** A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

#### HEALTH TESTING

The Irish Wolfhound Foundation will sponsor screening for cardiac health at the show site on Wednesday and Thursday, May 15 and 16. EKG/auscultation for OFA certification will be \$60.00. Echocardiogram/EKG will be \$175.00 for healthy dogs 2-7 years. An echocardiogram for dogs over 8 and dogs of any age with an equivocal EKG/auscultation will be \$100.00.

#### ATTENTION EXHIBITORS

- The State of New Mexico requires a Health certificate showing rabies vaccination within 12 months of entry for dogs 3 months of age or older.
- Tenting and ex-pen set up in designated areas only. There is no tent/ex-pen set up within 10 feet of the ring. NO STAKES will be allowed in the lawn due to underground irrigation.
- Please turn off cell phones and/or pagers before entering rings. Show Chairperson, Obedience & Rally Chairperson and Assistant Show Chairperson have the right to limit cell phone usage within 20 feet of the ring.
- DOGS MAY ARRIVE any time prior to their scheduled time of judging. DOGS NOT REQUIRED for further judging will be excused.
- JUDGES DO NOT HAVE TO WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called.
- THE SHOW-GIVING CLUB and the Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
- THE SHOW COMMITTEE/SUPERINTENDENT will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show as well as family, guests, and visitors in attendance.
- CANINE COURTESY. All dogs shall be kept under control at all times. You are responsible for picking up after the animals in your care. You may want to consider crate or X-Pen covers for the comfort of your dog.
- PLEASE EXERCISE DOGS IN DESIGNATED AREAS ONLY. There will be exercise areas with bags and containers for waste disposal placed around the grounds. PLEASE USE THEM. All regulations will be enforced by the Grounds Committee. Exhibitors and guests not picking up after their hounds or fouling the hotel rooms may be subject to a Show Bench Committee hearing and discipline.
- THE CLUB reserves the right to substitute a prize of equal or greater value.
- SHOW RING AND/OR OBEDIENCE/RALLY RING cannot be used for practice.
- DISRUPTIVE OR UNRULY BEHAVIOR by individuals or dogs on the show site will not be tolerated at any time. The AKC policies regarding dog aggression will be enforced.
- ONLY THE OFFICIAL SHOW PHOTOGRAPHERS are authorized to photograph win photos. Win photos are defined as dog and handler posed with the judge(s), ribbon(s)/ trophies.
